- Is not subject to a court order that restrains such person from harassing, stalking, or threatening an intimate partner of such person or child of such intimate partner
- Has not been convicted in any court of a misdemeanor crime of domestic violence;
- Currently resides in the same state as the buyer;
- Is of legal age, under both state and federal law, to sell a Title I weapon.
- Has provided all documents or licenses and/or fulfilled all State specific requirements.

- The purchaser certifies that he/she is not prohibited under state or federal law from purchasing a firearm and that he/she:
- Is not under indictment for, or has been convicted in any court of, a crime punishable by imprisonment for a term exceeding one year;

- Is not an unlawful user of or addicted to any controlled substance;
- Has not been adjudicated as a mental defective or has been committed to any mental institution;
- Is not illegally or unlawfully in the United States; except under a nonimmigrant visa;
- Has not been discharged from the Armed Forces under dishonorable conditions;
- Has not renounced his citizenship;
- Is not subject to a court order that restrains such person from harassing, stalking, or threatening an intimate partner of such person or child of such intimate partner
- Has not been convicted in any court of a misdemeanor crime of domestic violence;

- Is of legal age, under both state and federal law, to purchase a Title I weapon.
